## Paranormal Investigations Policy

### **How much do paranormal investigations cost?**

The cost to conduct a paranormal investigation is \$15/person per hour, in addition to a non-refundable deposit of \$250.

### **What is the minimum/maximum number of people I can bring?**

To book a paranormal investigation, you must have at least 4 people, but no more than 10 people. Please book your investigation for the total number of people who have confirmed their ability to participate at the time of booking. If you need to adjust the number of participants later, you may do so provided the change is made no later than five (5) days prior to the investigation.

### **When are paranormal investigations available?**

You can book a paranormal investigation any night, between June 1<sup>st</sup> and August 31<sup>st</sup>, between 7pm and midnight, based on availability. Investigations are not available in the winter months, and we will not book any investigations prior to Memorial Day of the year you wish to visit.

### **How do I book a paranormal investigation?**

### **Is a deposit required when booking a paranormal investigation?**

Yes, a \$250 deposit is required when booking your tour and the deposit must be received by the Wyoming Frontier Prison ten (10) days prior to the investigation. We will accept payment in the form of a two-party check, cashier's check, or money order only.

If you wish to cancel the investigation after we have received the deposit, you may do so five (5) days prior to the reserved date. Upon notice of your cancellation, we will refund your deposit within two (2) weeks.

### **If I am not a member of an official paranormal organization, can I still book an investigation?**

Yes, even if you are not part of an organized paranormal group, you can still book a paranormal investigation. Please keep in mind that it is the responsibility of the group to provide their own equipment and program. You also must have a minimum of 4 people in your group.

### **Do you book more than one paranormal investigation group on the same night?**

No. We do not book multiple paranormal investigation teams at the same time. Your group will be the only paranormal team in the building when you conduct your investigation.

### **Is there a minimum age requirement for paranormal investigations?**

Yes, anyone attending a paranormal investigation must be at least 18 years old.

### **Are there any special restrictions due to the Wyoming Frontier Prison's status on the National Register of Historic Places?**

Yes. The Wyoming Frontier Prison is listed on the National Register of Historic Places, and the preservation of the building and its artifacts is the primary focus of all activity on the property. All spaces must remain undisturbed. Nothing on the site may be moved, removed, touched or otherwise disturbed. Take nothing but photos and video, and please do not leave any trash or personal belongings behind.

## Paranormal Investigations Policy

### **What areas of the penitentiary will we have access to?**

During the investigation, the group will have access to all public areas as well as selected non-public areas of the penitentiary complex. To ensure the safety of the visitors and the historic site, several areas are off limits.

### **Will I be able to wander around on my own?**

No. Your group must stay together and will be accompanied by a member of our guide staff (minimum one guide per five visitors) at all times.

### **Can we bring cameras, video cameras, digital recorders, etc?**

Yes. It is the responsibility of the group to bring their own equipment and take it with them when they leave. The Wyoming Frontier Prison is not responsible for lost or damaged equipment.

### **What can't we bring?**

Please use your common sense. Alcohol and weapons are not permitted inside the penitentiary complex. Smoking is not permitted anywhere inside the penitentiary complex, including outdoor spaces within the walls.

### **When we arrive, is there a place we can set up?**

Groups are welcome to use the Warden's Office for staging (limited electricity is available) and are welcome to bring chairs, blankets, etc.

### **Is there electricity available?**

Yes, limited electricity is available in some areas of the penitentiary, but keep in mind that there are many areas that it is not available.

### **Will I have to fill out a waiver?**

Yes, everyone attending a paranormal investigation is required to fill out a waiver form. Waivers can be filled out in advance and can be provided prior to the investigation.

### **Is any additional insurance required?**

No additional insurance is required for paranormal investigations. However, the investigating group will be held responsible for any damage sustained by the property as a result of the investigation (before, during or after).
